The three court cases in the Court of Quebec with file numbers: 700-41-015582-215, 700-41-015583-213, 700-41-015581-217 are all together referred to as the "Three Court Cases" in this document.

The courts of Canada including but not limited to the Federal Court of Canada, the various Courts of Quebec as well as other Canadian provinces and all their agents and employees are all referred to as the "Courts of Canada" in this document.

The Centre Intégré de Santé et de Services Sociaux des Laurentides and all their branches, subsidiaries, agents and employees are all referred to as the CISSSLAU in this document.

Unless clearly specified otherwise, all words and phrases in this document are in plain english and french and can only to be interpreted in the light of their customary and generally accepted meaning as defined in general purpose english and french language dictionaries at the time of the officialization of this document. No other interpretation can be made other than the plain english and french one.

I, the living man on the land and soil jean-denis of the family boudreault with trade name: Jean-Denis Boudreault<sup>©™Ω</sup> (also known under the alternate trade name: Jean-Denis Joseph Gilbert Boudreault<sup>©™Ω</sup> and also under the alternate trade name: Joseph Gilbert Jean Denis Boudreault<sup>©™Ω</sup>), the affiant, of mature age, of sound mind, having standing and understanding both the spiritual and lawful liabilities of “thou shalt not bear false witness against thy neighbour” I do affirm and certify that the facts stated herein are true, correct, certain and complete to the best of my knowledge and understanding and I declare, affirm and say:

## Preamble

### *Temet Nosce*

I, a living man, A Living Soul, My blood flows and my Flesh lives, having Standing, so called by my biological Father and biological Mother since coming to life, jean-denis of the genealogy of boudreault also known by the common Trade Name: Jean-Denis Boudreault<sup>©™Ω</sup> (also known under the alternate Trade Name: Joseph Gilbert Jean Denis Boudreault<sup>©™Ω</sup> and also under the alternate Trade Name: Jean-Denis Joseph Gilbert Boudreault<sup>©™Ω</sup>) [ the “**Father**”, a component of “**We**” and “**Us**” and “**Our**” and “**Ourselves**” and also a component of the “**Parents**”], came to life the 18<sup>th</sup> day of March A.D. 1980, in the Sovereign Republic of Germany [unincorporated] and promptly returned (at the age of three months) and fully naturalized to my native land and soil generally referred to as "lower canada", also referred to as "quebec" and "canada" [all unincorporated] and I have *jus terra*. I am a free and natural man, a Freeman, a Sovereign, an Earl, described by the Lord God in Genesis 2:7 as a **Living Soul**, being of age, of sound mind and in good health, competent, with reason, with free will, always *sui juris*, *jus soli*, *jus sanguinis*, *paterfamilias et patria potestas*, *repraesentativum por tribus liberis viventibus* and living under God’s Law and His grace alone. I have assumed among the Powers of the Earth, granted by the Lord God Almighty, the Separate and Equal Station to which the Laws of Nature and Nature’s God entitle me, giving me dominion over all things.

I am also the biological Father and attorney-in-fact for my three (3) living **Children** and I have Claimed my **Children** on public record and I am head of my Family and I have *paterfamilias et patria potestas* over my entire Family and my living **Children** are my sole property. My three **Children** are a living girl and two living boys, living men, Living Souls, **Their** blood flows and **Their** Flesh lives, having Standing, so called by myself Their biological Father since coming to life: zia of the genealogy of boudreault with Trade Name: Zia Boudreault<sup>©™Ω</sup>, came to life on the 1<sup>st</sup> day of September A.D. 2011, lucas of the genealogy of boudreault with Trade Name: Lucas Boudreault<sup>©™Ω</sup>, came to life on the 7<sup>th</sup> day of June A.D. 2013 and raphael of the genealogy of boudreault with Trade Name: Raphael Boudreault<sup>©™Ω</sup>, came to life on the 3<sup>rd</sup> day of September A.D. 2016 [ the “**Children**”, all three also components of “**We**” and “**Us**” and “**Our**” and “**Ourselves**” and “**Their**” and “**They**” and “**Them**”] and all three came to life on the land and soil of Lower Canada also referred to as Quebec and Canada [all unincorporated] and all have *jus terra*. **They** are free and natural Children and men, Freeman, Sovereigns, Earls, *alieni juris* to me only as their *solus repraesentativum*, *jus soli*, *jus sanguinis*, described by the Lord God in Genesis 2:7 as **Living Souls**, living under God’s Law and His grace alone. **They** have assumed among the Powers of the Earth, granted by the Lord God Almighty, the Separate and Equal Station to which the Laws of Nature and Nature’s God entitle **Them**, giving **Them** dominion over all things.

I am sole attorney-in-fact and *procuratio* for my **Children** and I have *ius retentionis* and *ius praeferenendi* and I also have *ius retentionis* to keep my **Children** with me at all times. **They** are my sole property and I do not give any consent to anyone to take my **Children** away from me; *pirata non mutat dominium*.

My **Children** are NOT to be presumed abandoned by their biological Parents or dead, as **They** have been declared to be living on the public record multiple times, and **They** have been Claimed by their biological Parents and **Their** Deeds of Land Recording and Patents of Nativity have been fully published on the public record. **We** have been found to be living multiple times on the public record and I have also invoked on **Our** behalf Article IV of the Cestui Que Vie Act 1666

multiple times on the public record and before Her Majesty The Queen and *ergo* **We** have now been restored to **Our** proper roles for the CQV (the **Persons**).

I am a living man and the **Children** are living men, **Our** blood flows, **Our** flesh lives, **We** are Sovereigns and nothing stands between **Ourselves** and the Creator of all things that is. **Our** Patents of Nativity have been publicly recorded and published and **We** through our ancestors have been on this land since the 1630s A.D. and **We** have *Jus Soli, Jus Sanguinis et prioritatis* over any corporation or entity hereafter created.

By the unalienable and supreme right of self determination, **We** decide who and what **We** are and the roles **We** take and therefore I am the authorized agent and attorney-in-fact (*procuratio*) and Trust Donor (*curator personae*) and Beneficiary for the person (CQV) named: JEAN-DENIS BOUDREAULT<sup>©™Ω</sup> with birth date of March 18, 1980 [the “**Father Person**”, also all components of the “**Persons**” and the “**Parent Persons**”] that were deceptively created by the birth certificate registrations filed in error due to deceit and fraud and also using my **Copyrights** of my Trade Names. The person that I command is also known as the “Père” in these legal cases.

I am also the sole authorized agent and sole attorney-in-fact (*procuratio*) and sole Trust Donor (*curator personae*) for the persons (CQV) named: ZIA BOUDREAULT<sup>©™Ω</sup> with birth date of September 1, 2011, LUCAS BOUDREAULT<sup>©™Ω</sup> with birth date of June 7, 2013 and RAPHAEL BOUDREAULT<sup>©™Ω</sup> with birth date of September 3, 2016 [the “**Children Persons**”, also all components of the “**Persons**”] that were deceptively created using my **Children’s Copyrights** of **Their** Trade Names by the birth certificate registrations filed in error due to deceit and fraud. The living **Children** are the sole Beneficiaries for their respective **Children Persons**. The three **Children Persons** that I have authority over and that I command are known in each of the three individual legal cases as the “Enfant”.

For all the **Persons** (CQV) of the Family and with consent of Her Majesty The Queen, the state trustee is permanently assigned to the active Secretary of the Treasury Board at the Treasury Board of Canada Secretariat (the sitting officer at this time being Mr. Graham Flack) and in all *de-facto* (legal) courts, the role of trustee for the **Persons** is automatically assigned to the sitting judge (administrator) as **Our** trustee. The trustee is always accountable to me as the sole Donor for all the **Persons** trusts. If there is indeed a valid contract with the Province of Quebec corporation and it’s government corporation (as the state), then the Plaintiff as an agency of the state is **Our** trustee also.

I am the head of my Family, I have *paterfamilias et patria potestas* over my entire Family and I speak for myself *sui juris* and as attorney-in-fact and *repraesentativum por tribus liberis viventibus*, which are *alieni juris* to me only.

In order to further clarify, I the living man :jean-denis;. boudreault: am not the person named (with all capital casing): JEAN-DENIS BOUDREAULT<sup>©™</sup>, but I am rather the sole Donor and Beneficiary for this person which is in fact only my “*alter ego*”. My living daughter :zia;. boudreault: is not the person named (with all capital casing): ZIA BOUDREAULT<sup>©™</sup> but I am rather the sole Donor and she is the sole Beneficiary for this person which is in fact only her “*alter ego*”. My living son :lucas;. boudreault: is not the person named (with all capital casing): LUCAS BOUDREAULT<sup>©™</sup> but I am rather the sole Donor and he is the sole Beneficiary for this person which is in fact only his “*alter ego*”. My living son :raphael;. boudreault: is not the person named (with all capital casing): RAPHAEL BOUDREAULT<sup>©™</sup> but I am rather the sole Donor and he is the sole Beneficiary for this person which is in fact only his “*alter ego*”. To presume that **We** living men are the **Persons** is willful unlawful conversion and *crimen falsi*.

The Family “trust relationship” through the right of self determination can never be presumed to be anything other than:

- myself the biological Father and *paterfamilias et patria potestas* as the sole Trust Donor;
- the **Children** are always the sole Beneficiaries and;
- the role of **Our** trustee for the **Persons** is always permanently assigned to the various government service corporations such as Canada, Quebec, United Nations government service corporations and others such as the Plaintiff and the courts when applicable. The primary and permanent trustee for our Family “trust relationship” is currently assigned to the active Secretary of the Treasury Board at the Treasury Board of Canada Secretariat and in all *de-facto* (legal) courts, the role of our Family trustee is automatically assigned to the sitting judge

(administrator) as **Our** trustee. If there is indeed a valid contract with the Province of Quebec corporation and it's government corporation (as the state), then the Plaintiff as an agency of the state is **Our** trustee also.

I am the sole and only Guardian of my **Children**, and the **Father Person** is the sole Guardian on the **Children Persons**. I do not consent at any moment and in any way, shape or form for my **Children** to be taken away from me. The **Father Person** is NOT the "tutor" (or in other words the trustee) for the **Children Persons**, but rather is the sole and permanent Guardian.

**We** are peaceful men, **We** desire to live in Peace and Harmony with **Our** fellow man on the soil and land and with the protection of God and the Law of the land in terra iurisdictionis and jus terra. **We** shall live by the commandment of "Love thy Neighbor" and shall "Do no Harm" in **Our** private pursuit of Life, Freedom, Liberty, Happiness and shall Live in Peace.

## **Sovereign nation states**

**We** and **Our Persons** are not domiciled in and citizens, residents, subjects and employees of any foreign corporation such as but not limited to the United Nations, the UN, the Canada, the Government of Canada, the Crown, the Province of Quebec and the Government of Quebec service corporations and **We** and **Our Persons** are all not for hire and remain at all times "at arm's length". **We** and **Our Persons** are always and only nationals of the land nation of Canada [unincorporated] and our own nation states and are always and only in the land jurisdiction and **We** and **Our Persons** are always and only "foreign nationals" (as defined in the Immigration and Refugee Protection Act (S.C. 2001, c. 27) ) relative to all corporations and **Our** estates and/or trusts are TAX-EXEMPT as a "exempt foreign trust" or "foreign estate or trust." (as defined in the Income Tax Act (R.S.C., 1985, c. 1 (5th Supp.))). By the superior Laws of God and the supreme right of self-determination (Article 1.1, 1.2 and 1.3 of the ICCPR), **We**, Living Souls and having Standing have self-determined that **Our Persons** as our person and suit are sovereign and are each declared to be a "**foreign state**" as acting in such public capacity (as defined in the State Immunity Act (R.S.C., 1985, c. S-18), hereafter the "SIA"), as "**foreign state: includes (a) any sovereign or other head of the "foreign state" or of any political subdivision of the "foreign state" while acting as such in a public capacity, [...]**") relative to all corporations and with respect to jurisdiction immunity of foreign nations, see SIA. That respect is dictated by the maxim, lying at the heart of the international legal structure, that **all states are sovereign and equal**, see Article 2(1) of the Charter of the United Nations. **We** and **Our Persons** now have at all times jurisdiction immunity and full limited diplomatic immunity as foreign states and as ones who created government as per the Geneva conventions. **We** fully respect Her Majesty The Queen's or His Majesty The King's sovereignty and diplomatic immunity, Canada's sovereignty and diplomatic immunity, Quebec's sovereignty and diplomatic immunity and all other corporation's sovereignty and diplomatic immunity, and by the rules and doctrines of international reciprocity and comity, **We** demand that **Our** sovereignty and diplomatic immunity be respected also.

## The nine (9) elements of a valid contract.

ALL agreements and contracts must respect all nine of these conditions without exception. Any breach of any single one or more of these conditions automatically vitiates the contract and it becomes unenforceable, null and void *ab initio*.

1. **Parties competent to contract:** The parties to a contract should be competent, being of the age of consent, of sound mind, not disqualified from contracting by any law to which he/she is subject. A flaw in capacity may be due to minority, lunacy, idiocy, drunkenness, or dissimilarity of kind. The parties should be of the same kind, being either legal fiction actors, or natural living men/Women, allowing more than two parties, but never a mixture of these kinds and their respective jurisdictions.
2. **Free and genuine consent:** The consent of the parties to the agreement must be free and genuine. The consent of the parties should not be obtained by misrepresentation, fraud, undue influence, coercion or mistake. If the consent is obtained by any of these means, then the contract is not valid or legally/lawfully enforceable.
3. **Full disclosure:** When negotiating a contract, full disclosure is the step of providing all material information, or telling the “whole truth”, about any matter which may influence the decision-making of the other party or parties before they decide to enter into a contract. If either party fails to make full disclosure, the contract is null and void.
4. **Valuable consideration:** The consideration is something of value possessed by the parties that is brought to the contract table. This something of value is bargained for and given in exchange for a promise or a performance. The parties must each receive a benefit and each suffer a detriment. To be enforceable, a contract must have valuable consideration. A contract is unenforceable if it has insufficient or unequal consideration without agreement.
5. **Certainty of terms:** The Terms and Conditions of the contract must be fully disclosed and agreed upon, and must be certain and fixed. Any subsequent variation of terms must be agreed.
6. **Meeting of the minds:** A meeting of the minds “consensus ad idem”, occurs between the parties when they recognize each other, understand their mutual obligations, and agree. A meeting of the minds occurs between living men/Women in lawful matters (Common Law jurisdiction), and between legal fiction actors in legal matters (Admiralty Maritime jurisdiction). A contract must be either Lawful or Legal. If one party to a contract makes a “signature” as an “accommodation party” to a legal fiction person, while the other party makes an “autograph” for a living man or Woman, the parties are of unequal kinds, and the contract is null & void.
7. **Autographs or Signatures:** Lawful written contracts between living men/Women must carry the wet ink autographs of the parties, comprising living identification such as a thumbprint, but more often living standing is recognized by an unambiguous declaration with the handwritten wet ink autograph, including the prefix “By:”, and/or the words “All Rights Reserved,” and “Without Prejudice,” written below. Legal written contracts between legal fiction actors must carry the wet ink signatures of the parties, as an accommodation from a man/Woman.
8. **Privity of contract:** A contract exists only between the parties. No third-party can obtain rights contained within a contract, or buy or sell a contract, without the express permission of the original parties.  
  
The Quebec civil code contains the same provision known in French as “Effet relatif du contrat” and is clearly expressed in RLRQ c CCQ-1991, art 1440: “A contract has effect only between the contracting parties; it does not affect third persons, except where provided by law.”
9. **Good faith and Honesty:** Contracting parties must be able to rely on a minimum standard of honesty from their contracting partner, especially from the “weightier” side. “Bad faith” in contracting is dishonesty and can easily become fraud, hence it’s widespread recognition in case law. Bad faith or dishonesty is therefore a vitiating factor.

I, the living man on the land and soil jean-denis of the family of boudreault (:jean-denis;. boudreault:) with Trade Name: Jean-Denis Boudreault<sup>©™Ω</sup> (also known under the alternate Trade Name: Jean-Denis Joseph Gilbert Boudreault<sup>©™Ω</sup> and also under the alternate Trade name: Joseph Gilbert Jean Denis Boudreault<sup>©™Ω</sup>), the affiant, of mature age, of sound mind, a sovereign, having Standing and my word being second only to God, competent to testify, having first hand knowledge of the facts set forth herein and understanding both the spiritual and lawful liabilities of “Thou shalt not bear false witness against thy neighbour” and giving this testimony of my own free will and accord I do solemnly affirm and declare that the facts stated herein are true, correct, certain and complete to the best of my knowledge and understanding and under the penalty of perjury with the intent that it have the full force and effect of an affidavit. My Living Testimony, in the form of and part of this Affidavit shall be truth in fact upon the record. It is un-rebutted, precept by precept, and shall become *de jure* judgment upon the record. Therefore I, :jean-denis;. boudreault: solemnly declare, testify, affirm and say:

## Section 1 - Statements about the sovereign men and their nation states

### Article 1)

I, :jean-denis;. boudreault:, a Living Soul, a man of God, *Sui Juris*, affirm, declare and state for the record that **We** (I myself and my three living **Children** so called by myself their biological Father: zia, lucas and raphael, all three claimed and rightful heirs of the boudreault family) have all been claimed by their biological Parents and found to be living on the public record multiple times and **We** have also invoked on **Our** own behalf Article IV of the Cestui Que Vie Act 1666 multiple times on the public record and *ergo* **We** have now been restored to **Our** proper and rightful roles as Donor and Beneficiaries for the **Persons** (CQV) created with **Our** life Assets. I also state for the record that I am sole attorney-in-fact and *procuratio* and guardian for my **Children**. These are my **Children** and I have *ius retentionis* and *ius praeferendi* and I also have *ius retentionis* to keep my **Children** with me.

### Article 2)

I, :jean-denis;. boudreault:, affirm, declare and state for the record that I am the biological Father of my three living **Children**, I am the head of **Our** Family, I am sole attorney-in-fact for my **Children**, they are my sole property and I have Common Law *paterfamilias et patria potestas* over my entire Family.

### Article 3)

I, :jean-denis;. boudreault:, affirm, declare and state for the record that I am the sole Donor and sole Beneficiary for the Father Person (CQV and fictional entity) named: JEAN-DENIS BOUDREAUULT<sup>©™Ω</sup> with birth date of March 18, 1980. I also state for the record that I am the sole attorney-in-fact, guardian and Donor and the **Father Person** is attorney-in-fact and guardian for the **Children Persons** (CQV and fictional entities) named: ZIA BOUDREAUULT<sup>©™Ω</sup> with birth date of September 1, 2011, LUCAS BOUDREAUULT<sup>©™Ω</sup> with birth date of June 7, 2013 and RAPHAEL BOUDREAUULT<sup>©™Ω</sup> with birth date of September 3, 2016. I also state for the record that **We** are living men imbued with a Living Soul, and **We** are NOT persons and **We** are NOT the **Persons**.

### Article 4)

I, :jean-denis;. boudreault:, affirm, declare and state for the record that my lawful wife is katherine of the family of boudreault and the **Father Person** is married with her own person and trust named: KATHERINE SIAVICHAY<sup>©™Ω</sup> with birth date of May 29, 1980.

### Article 5)

I, :jean-denis;. boudreault;, affirm, declare and state for the record that on the 19<sup>th</sup> of September, 2022 I two contacted agents of the CISSSLAU by email in order to offer them a deal out of good faith whereas despite all the crimes and pain they have committed, that I was ready to forgive them, their attorneys and the administrators in full if they ceased and desisted from the Three Court Cases and I was safely back with my **Children** before the 1<sup>st</sup> of October, 2022 and if these conditions were not met within this time frame, that the full force of the judicial system of the State of Jean-Denis Boudreault<sup>®™</sup> would be invoked in order to render justice to all involved actors and stop the ongoing crimes.




